

Agenda No. 2. To consider for admission into PG Sem-I 2015-16 session.


Resolutions : The committee considered the Resolution of the meeting of AC held on 16.03.2015 at Agenda No. 2 regarding the prospectus and the format for application form and resolved that process of admission into PG Sem-I of 2015-16 session be initiated and completed as per dates hereunder.

- i) Date of Application form to be available from : 01.09.2015
- ii) Last date of submission of Application form : 15.09.2015
- iii) Publication of Ist Merit list for admission (Deptt. wise /centre wise) : 21.09.2015

Resolutions : The committee resolved that since choice-based-credit system was to be implemented and it would take a few days time to update the prospectus, by that time only the form should be printed and made available to students, whether to apply for University Departments or P.G. centers, with a cost of Rs. 200/- for application form and Rs. 100/- for Prospectus.

The application form should be made available by 01.09.2015 but the prospectus with necessary & relevant information be made available by the time of admission at the cost of Rs. 100/- only. Further resolved that proper care must be taken to incorporate in the prospectus complete details of the Univ. Deptts. and P. G. Centres

along with relevant information regarding at least the subjects and their HoDs.

Further resolved that D.S.W. should be authorized to hold a meeting with the Principals of P.G. Centres for arriving at Uniformity under other heads of fee structure whereas the tuition and Admission fees should remain the same as that for University Department.


Further, the Committee considered and resolved that 10% seats under each category, whether General (unreserved) or Reserved category, be allotted to applicants belonging to other defined categories, such as Sports, Culture, NCC, NSS and differently abled but never exceeding one seat in each category as above.


Agenda No. 4. To consider for information to Colleges for admission into Deg.-I 2015-16 on enhanced seats in anticipation of approval of the State Govt.

Resolutions : The Committee considered the matter and resolved that though the University had requested the State Govt. for enhancement of seats for admission into Deg.-I in Arts/Science and Commerce @ 25% and 50% respectively, the permission would only be given when approval of the Govt. would be obtained.

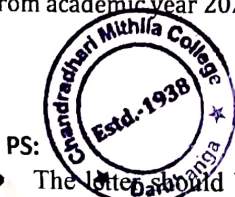
